

Each year during the ISHP Fall Conference, pharmacy professionals throughout Idaho are recognized for their service to the organization and dedication to the field of pharmacy. This year's winners, like the many before them, are outstanding representations of leadership and innovation. Our award winners actively took on roles to improve patient care and expand access to critical clinical services – all while battling the challenges of a global pandemic!

# **Pharmacist of the Year**

# Nikki Chopski, PharmD

Executive Officer - Idaho State Board of Pharmacy



"Dr. Chopski is an innovator and an icon in the practice of pharmacy in Idaho. Through her role when she served as the Chair of the Board of Pharmacy, she innovated and advanced the practice of pharmacy significantly expanding the scope of practice for Idaho pharmacists, and more importantly increased access to healthcare services in communities throughout the state of Idaho. Examples of this advancement include broad independent pharmacist prescribing privileges for pharmacists in all practice settings, streamlined facility regulation, and advanced delegation authority allowing for an increased role for pharmacy technicians in all practice settings... After Idaho pharmacists were given provider status with Idaho Medicaid through a

regulatory change, Dr. Chopski worked with Idaho Medicaid to auto-enroll pharmacists as providers to facilitate broader access to COVID-19 testing and immunization services for Idaho's most vulnerable patients. In addition, she worked with the Idaho Coronavirus Financial Advisory Committee to administer a grant using CARES Act funding to stand up COVID-19 testing in pharmacies across the state."

#### **Technician of the Year**

#### Kathleen O'Dell, CPhT

Pharmacy Technician – St. Luke's Cystic Fibrosis Center of Idaho

"Kathleen has had a long career dedicated to providing service to the pharmacy profession. After spending many years at the Boise VAMC as a technician leader she took a leap to develop her clinical skills at the St. Luke's Cystic Fibrosis Center of Idaho. She has allowed our clinic staff to work at the top of our licenses while working at the top of hers. In the year 2021 she has already saved nursing and physicians over 136 hours of work by taking over prior authorizations and refill requests. The true measure of her work cannot be calculated by metrics, and this is evidenced by a quote from one of our directing physicians who noted "pharmacy is the single best team addition that the CF clinic has ever had". Our patients love working with her and one recently told us 'If it wasn't for Kathleen I would not take my medications'."

"Dr. O'Connor is a champion of pharmacy practice advancement in Idaho. # **ASHP House of Delegates**



#### **Paul Driver and Heather Walser**

The policies that were passed by the ASHP House of Delegates (HOD) last June were published in AJHP November 1<sup>st</sup> issue. Please take some time and review those policies. There is a scheduled virtual house voting meeting from November 12<sup>th</sup> to the 19<sup>th</sup>. In this voting session the House will not be able to amend the policies but vote to accept them or defer them to the June meeting 2022. There are six polices to be considered. None of the policies under consideration are new. Five of them are updates of prior policies and one is to discontinue an existing policy. The policy titles and very brief synopsis of changes are below:

**Agricultural Use of Hormone and Prohormone Therapy** – This policy is expanding the original policy to advocate for elimination of nontherapeutic uses of hormonal treatments in animals and that when used should only be under the supervision of a veterinarian.

**Pharmacist's Role in Healthcare Information Systems** – This policy is primarily updating some of the wording to fit with current usage and reenforce the role of the pharmacists in informatics.

**Reduction of Unused Prescription Drug Products** – This policy is updating the language to be more inclusive of the pharmacy workforce and well as expanding the pharmacist role in excessive prescribing by advocating and educating providers and patients on quantities that are reasonably dispensed to reduce waste.

**Expiration Dating of Pharmaceutical Products** – This policy is more forceful in promotion of manufactures to update expiration dates and use current evidence of stability to extend existing date labeled products to be used to help with the drug shortages.

**Elimination of the Apothecary System** – This policy is recommended to be discontinued as essentially all drug orders are now in metric units and not in apothecary units.

**Covid-19 Vaccination Requirements to Advance Patient Safety and Public Health** – This policy was approved in June 2021 HOD meeting. However, since it was approved, all of the Covid vaccines used in the United States have become approved by the FDA. The original policy was in regards to Emergency Use Authorization (EUA). The EUA verbiage has been removed.

If you have any thoughts on this, please let Heather or Paul know as soon as possible. The voting is scheduled to begin November 12<sup>th</sup> and end November 19<sup>th</sup>. We realize this is a narrow window but please let your voice be heard if you have any comments on these policies.

#### New Class of 2022

The Idaho Pharmacy Leadership, Advancement & Development Program (I-LEAD) welcomed its  $4^{th}$  class of leadership fellows this past month (officially the class of 2022)! The class is our largest to date with five Pharmacists and three Pharmacy Technicians representing practice areas from across the state.

Going into this fourth year of ILEAD, the program administrators will continue the newly established quarter system, dividing up the year into the four domains of Leading Self, Leading Others, Leading Organizations, and Leading with Influence & Strategy. 
